# CAREing for Children

We at Ocean County Business Association are pleased to present the Tenth Annual Marty Aronow Charity Golf Classic. In 2015, with the passing of Marty, the Board of Directors decided to rename our annual golf outing in his honor.

Last year's outing raised \$22,000. Those funds were used to buy gifts and food which were then donated to under privileged children and families. These gifts have been distributed by CAREing for Children (CFC) to charitable organizations in Ocean County. A few examples are Providence House, Faith Community Church Food Pantry, the Salvation Army, St. Joseph's Church, the United Methodist Church Food Pantries and many more.

We are well aware of the challenges of the past few years and the need is ever growing. CAREing for Children was the vision of its chairwoman and one of its founding members, Clare Bojus, who passed away in February 2022. Her loving spirit lives on with new leadership under the direction of Barbara Farley, who had worked with Clare for many years.

Because CFC is run strictly on a volunteer basis, there are no overhead costs as 100% of all donations go to support those in need. Additionally, 100% of the Golf Classic's net proceeds are funneled directly to CFC. Over the first 9 years of the event, we have raised and donated over \$182,000 worth of food and children's toys to the community. Additionally, in both 2024 and 2025 we donated 100 backpacks stuffed with school supplies to children in need.

This CAREing for Children program is close to our hearts and one that we hope you agree is worth your involvement and the support of your time, money, & effort.
